



# Philipp Schwartz and Inspireurope Stakeholder Forum

22-24 May 2023 | Berlin



## Agenda

The 2023 Philipp Schwartz and Inspireurope Stakeholder Forum, convened by the Alexander von Humboldt Foundation's Philipp Schwartz Initiative and Inspireurope+, will bring together up to 400 scholars, host institutions, and partner organisations across Europe to address topics related to the protection of academic freedom and the support of researchers at risk. Researchers, administrators and other stakeholders will present their perspectives on institutional, national, European and global initiatives to promote academic freedom and support scholars. A particular focus will be placed on mutual learning opportunities for at-risk scholars, academic mentors, and administrators working to support at-risk academics and to strengthen academic freedom. European and national government officials and other policymakers will also participate alongside representatives from NGOs, SAR sections, and higher education institutions across Europe.

The conference language will be English. Parts of the programme will be available online via online streaming (day 1) and through hybrid virtual rooms (day 2). The times indicated represent Central European Summer Time. Please note that this event is by invitation only and requires advance registration.

# The Philipp Schwartz Initiative

Under the Philipp Schwartz Initiative, the Alexander von Humboldt Foundation has been granting funding to universities and research institutions in Germany to host threatened researchers for a period of two years since 2016. The host institutions receive funding that com-



pletely covers the costs of a research fellowship or an employment contract. Sponsorship can be extended by one year under a co-financing model. In addition, the host institution is granted an allowance of € 20,000 per individual sponsored. This financial support is complemented by the provision of a platform to connect host institutions, researchers at risk and other organisations active in this field. Its highlight is the annual Philipp Schwartz Forum. So far, 454 researchers from 26 countries have been sponsored under the Philipp Schwartz Initiative.

#### Who was Philipp Schwartz?

The pathologist Philipp Schwartz (\*19 / 07 / 1894) became a professor of pathology at Goethe University Frankfurt in 1927. Being from a Jewish family, he was summarily dismissed from the university in 1933 when the National Socialists seized power. He fled to Switzerland where



he founded the "Notgemeinschaft deutscher Wissenschaftler im Ausland" (Emergency Society of German Scholars Abroad) in the same year. Its aim was to find employment abroad for persecuted academics. The organisation interceded on behalf of several hundred refugee researchers. Most of them went to Turkey, where Kemal Atatürk was in the process of reforming the higher education system based on the Western European model. Schwartz personally negotiated with representatives of the Turkish government and immediately managed to secure places there for 30 researchers who had been dismissed from posts in Germany. The Emergency Society also cooperated with the Academic Assistance Council, the predecessor of the Council for At-Risk Academics. In 1934, Schwartz himself accepted a chair at the newly established Istanbul University, becoming director of the Institute of Pathology. After the Second World War, his desired return to Frankfurt University as a professor was denied him. He emigrated to the United States in the early 1950s and continued to work as a pathologist at Warren State Hospital in Pennsylvania, where he headed a geriatric research institute from 1967 onwards. Schwartz died in the United States in 1977.

Building on the work undertaken by the Inspireurope project (2019—2022), and under the lead of Scholars at Risk Europe at Maynooth University, Ireland, Inspireurope+ proceeds from the view that excellence in research depends upon free and open scientific debate and requires a diversity of perspectives and methodologies to flourish. Inspireurope+ partners will coordinate activities across Europe to support researchers at risk until 2025. This includes direct guidance through webinars and trainings, building institutional capacity and preparedness for support, advising national-level initiatives, informing European policy, and raising awareness to diversify support for researchers at risk in Europe.

### **Academics in Solidarity**

For the coaching sessions in Track 1 on Wednesday, the Philipp Schwartz Initiative is proud to partner with "Academics in Solidarity" (AiS), drawing on their immense experience as a peer-mentoring programme that connects exiled researchers and established scholars in Germany, Lebanon and Jordan. It seeks to create a network of solidarity, strengthen the value of cross-cultural research cooperation and open up new perspectives within the academic environment of the host country. AiS offers support to displaced and endangered scholars through mentoring, academic counselling, systematic network building, and funding of small research endeavors. It further benefits mentors by offering them special training as well as administrative and technical support both prior to and throughout the mentoring process. The project was funded by the Federal Ministry of Education and Research (BMBF) and is currently funded and hosted by Freie Universität Berlin.

## **Event Information**

The first day of the 2023 Philipp Schwartz and Inspireurope Stakeholder Forum will take place at the Henry Ford Building of Freie Universität Berlin. Founded by professors and students in response to the persecution of dissident students at the former Universität Unter den Linden in the then Soviet sector of the divided Berlin, Freie Universität has academic freedom in its DNA. As one of the first German members of the Scholars at Risk Network, it has upheld its tradition of protecting academic freedom and of supporting researchers and students at risk. A regular host to the Alexander von Humboldt Foundation's Annual Meeting, Freie Universität also co-hosted the 2018 Scholars at Risk Global Congress together with the Scholars at Risk Network and the Alexander von Humboldt Foundation.

The second day of the Forum will take place at "Cafe International" on Karl-Marx-Allee. This land-mark of Socialist modernist architecture was built in East Berlin as a residential complex from 1961—1964, aspiring to represent a new, "international" style, characterized by a focus on transparency, reflections, and interrelatedness of inside and outside spaces. During the time of the German Democratic Republic (GDR) the building was used as a cafe and restaurant for the political elite. Its original name "Cafe Moskau" is rooted in the building's and the city's history, referring to the ties between the GDR and the Soviet Union at the time. Since 2009 the venue has been owned and managed by a private German-American corporation.

In light of the Russian Federation's war of aggression against Ukraine, the Alexander von Humboldt Foundation has obtained permission to temporarily rename the venue to "Cafe International" for the Philipp Schwartz and Inspireurope Stakeholder Forum, referring to the equally historic "Kino International" across the street and emphasizing the spirit of the event. We hope that the venue's entangled history will inspire discussions on how to reconcile our perceptions of the past with current affairs.

There will be a bus transfer between hotels Meliá and INNSIDE Berlin Mitte and the venues before the start of the programme at each venue. Alternatively, you can reach the Henry Ford Building by taking the U3 subway line via the stop Freie Universität. You can reach Cafe International with the subway line U5 via the stop Schillingstraße at Cafe International.

Parts of the programme will be offered as a hybrid event, other parts of the first day will be offered via livestream in the event app and on the Humboldt Foundation's YouTube channel.




# **Venue Map**



#### **Enno Aufderheide**

Dr. Enno Aufderheide is the Secretary General of the Alexander von Humboldt Foundation. He previously held positions at the German Aerospace Centre, served as head of the Research Department at the German Council of Science and Humanities, as executive director of the Helmholtz Association, and as head of the Research Policy and External Relations Department at the Max Planck Society. He also managed the Minerva Foundation for the promotion of German-Israeli academic cooperation. He has been a member of national and international committees for the promotion of science and authored numerous academic and science policy publications, for which he received distinctions such as the Kussmaul Medal of the German Society for Rheumatology. An alumnus of the German National Academic Foundation, he studied biology at the universities of Bielefeld and Bonn and was a Fulbright Fellow at the University of Colorado in Boulder, USA. 
