Agenda

The 2023 Philipp Schwartz and Inspireurope Stakeholder Forum, convened by the Alexander von Humboldt Foundation's Philipp Schwartz Initiative and Inspireurope+, will bring together up to 500 scholars, host institutions, partner organisations across Europe to address topics related to the protection of academic freedom and the support of researchers at risk. Researchers, administrators and other stakeholders will present their perspectives on institutional, national, European and global initiatives to promote academic freedom and support scholars. A particular focus will be placed on mutual learning opportunities for at-risk scholars, academic mentors, and administrators working to support at-risk academics and to strengthen academic freedom. European and national government officials and other policymakers will also participate alongside representatives from NGOs, SAR sections, and higher education institutions across Europe.

The conference language will be English. Parts of the programme will be available online via online streaming (day 1) and through hybrid virtual rooms (day 2). The times indicated represent Central European Summer Time. Please note that this event is by invitation only and requires advance registration.

ais	1a: Trainings for Scholars : on-site only, AvH/AiS to lead For the training sessions in this track, the organisers are proud to partner with "Academics in Solidarity", a peer-mentoring program that connects displaced and at-risk researchers. It seeks to create a network of solidarity, strengthen transnational research cooperation and offers university support to members of the AiS network. The project has been funded by the Federal Ministry of Education and Research (BMBF) and is currently funded and hosted by the Freie Universität Berlin.
	<i>I) Navigating the German and European Research Funding Landscape</i> This training will give an overview of the fundraising landscape in Germany and the EU and give a deeper insight into how to approach the fundraising process in science.
	<i>II) Paid to Research: How to Prepare Successful Funding Applications</i> This workshop supports participants in learning how to adequately prepare and write their own successful applications for scholarships and research funding (both in Germany and beyond).
	<i>III) Transitioning from Research to the Market</i> This workshop supports scientists in developing projects to bring their research to the market. It gives insights to grant applications for collaborative projects with industries, specific industry funding programs and advice on building start-up projects.
	<i>IV) Digital Repression: Methods, Risks and Responses</i> This workshop gives an overview of methods of digital transnational repression targeting political exiles and diaspora communities, discusses specific risks of exiled scholars and introduces concrete actions and tools to reduce digital repression.
	<i>V) The Mobile Researcher</i> This workshop discusses how to cope with forced and desired mobility in academia. This workshop discusses how to withstand the pressure of academic performance as a mobile and displaced researcher and touches upon practicalities of movement, such as networking, finding employment between positions and coping with the stress of moving places.
	<i>VI)</i> Your Career Path as a Scientist: Gaining Clarity This workshop supports scholars in building a professional identity as a scientist and gaining clarity on how to navigate the research scene within and beyond academia as a researcher.

	<i>VII) Safer Fieldwork for Social Sciences</i> Fieldwork on repression, armed conflict and other sensitive topics is increasingly dangerous for both researchers and their interlocuters. This workshop introduces basic concepts of research risk and safety when doing fieldwork in sensitive environments.
	VIII) The Legal Status of At-Risk Researchers: Knowing your Rights This workshop gives insights to the legal framework conditions for working in German research institutions as well as those pursuing a research activity in industry or companies. It gives an overview of German and EU migration law, gives insights into how to deal with one's changing legal status, the advantages and disadvantages of certain residence permits, how to approach rights of residency when a fellowship is ending and discusses matters of movement as a researcher with the EU.

The Russian invasion in Ukraine has led the establishment of new support programmes for researchers at risk. While many are designed as a temporary measure, this might prepare the ground for long-term programmes with a broader regional focus. Existing support programmes on the national or local level may provide models for those willing to develop such long-term programmes or activities elsewhere. In this session, aimed at representatives of SAR sections and individual institutions across Europe interested in organising at the national-level, representatives from long-established, newly formed or developing programmes will share insights into what is necessary and helpful to establish a support programmes for researchers at risk.
