As part of the Inspireurope+ project, on 23 October 2023 the Aristotle University of Thessaloniki organised a roundtable for university leaders across Southern and Eastern Europe. The roundtable gathered 25 university leaders, including rectors, vice-rectors, international directors from institutions across Albania, Bosnia and Herzegovina, Bulgaria, Cyprus, France, Montenegro, North Macedonia, Serbia, Spain, Slovakia, and Greece. Calls for proposals for co-funded fellowship schemes and staff exchanges are now open and may be of interest to researchers at risk and their host organisations. Academic Freedom Monitoring Report

The annual report by Scholars at Risk's Academic Freedom Monitoring Project Free to Think 2023, analyses attacks on academic freedom around the world. The report was formally launched on 9 November 2023 at the Second Conference on Academic Freedom in the Americas. This year's report covers 409 attacks and highlights the situations in 16 countries and territories. The report emphasises the devastating impact of attacks against higher education communities and calls on readers to take a range of actions that can help protect scholars and students and safeguard academic freedom. Cara's 90th Anniversary Event

Cara (the Council for At-Risk Academics) and the Royal Society co-hosted a 90th anniversary event on the evening of 11 September. Professor Robin Perutz FRS, son of the Nobel Prize winner Max Perutz, spoke about 'Cara Past', including the story of his parents met in the 1930s thanks to what is now Cara. 'Cara Present' included presentations by current Cara Fellows from Afghanistan and Myanmar, and a 'Researchers at Risk' Fellow from Ukraine. Cara's Chair, Professor Alan McCarthy, set out his vision of 'Cara Future'. Professor Jon Keating, FRS provided opening and closing remarks, and Cara's Director, Stephen Wordsworth, introduced the individual speakers. View the recording >>
